COVID-19 Vaccine

Ohio's first shipments of the COVID-19 [vaccine](#) have arrived in Ohio. Shipments were delivered to [10 prepositioned hospital sites](#) based on geography, population, and ultra-cold storage capacity.

Healthcare workers caring for COVID-positive patients are the first to begin receiving vaccinations as part of Ohio's [Phase 1A distribution](#). A scaled launch of vaccinations at Ohio nursing homes began on Friday, Dec. 18.

Local health departments are expected to begin receiving shipments of the vaccine during the week of December 28. [The Ohio Department of Health issued guidance to health departments on vaccine prioritization.](#)

Right now, vaccine supplies are limited and not yet available for the general public. Vaccine prioritization for [Phases 2, 3, and 4](#) are still being developed by the Ohio Department of Health.

A new vaccination dashboard is now available at coronavirus.ohio.gov. The dashboard tracks the number of people vaccinated and is sortable by demographic and by county.

Other Updates


The majority of students in Ohio K-12 schools are currently learning remotely. Approximately 45% of students are fully remote; 28% are attending school in-person full-time; 26% are a hybrid of both.

Ohio's 10 p.m. to 5 a.m. curfew remains in effect until at least January 2.

TALKING POINTS FOR YOU

Vaccines are now being distributed in Ohio, but they are not yet available to the general public. Ohio is taking a phased approach at vaccine distribution – beginning with the healthcare workers who are interacting with COVID-19 patients every day.

The state is still working to determine when the vaccine will be made available to the general public. Until then, citizens should continue practicing safety measures such as social distancing, mask-wearing, and hand washing. You are encouraged to stay home as much as possible and to avoid interacting face-to-face with those outside of your household.

The end of December is a very critical time in the fight against the coronavirus. It's critically important that citizens celebrate safe and celebrate small. Remember – not everyone shows symptoms of COVID-19, and it's possible to get the virus from family and friends.

By sacrificing big gatherings and large family get-togethers in 2020, we all have a better chance of celebrating together in 2021.

Please use these talking points and social media posts to help amplify the message about the importance of slowing the spread of COVID-19. High spread impacts the health of your employees and the public. Encouraging safe practices will help slow the spread in your community.

WAYS YOU CAN HELP
